

**EFFECTIVE MARCH 1, 2011**



- Community Health Centers of Lane County are non-profit medical practices with quality affordable healthcare services.
- We will bill Medicaid, Medicare, Oregon Health Plan, and other commercial insurances.
- Community Health Centers of Lane County are NOT free clinics.
  - Those without insurance are charged on a sliding discount scale based on family size and income according to the federal poverty guidelines.
- **Verification of income is required to receive a discount.**
- **Appointments are required.**

**HOUSEHOLD INCOME VERIFICATION  
IS REQUIRED TO RECEIVE A DISCOUNT**

- You will not be able to be seen until you bring verification of income.
- Income information needs to be updated every six months.

**VERIFICATION OF INCOME:** Include income from all members of the household that are counted in the household number. Example: if you live with your adult children and count them in the household, their income must be included.

**Acceptable forms of proof include:**

- **Pay stubs** for the current month and last 2 months.
- **Check stubs or letter of determination for:** Child support/alimony check, unemployment, DHS/AFS, SSI, etc.
- **Student financial aid:** financial aid award letter
- For self-employed applicants, **last year's tax return.**

**For patients with no job or other income source:**

- **One letter** from an agency who knows the situation and is or has recently been providing services to the applicant (letter signed, dated and on agency's letterhead), **OR**
- **No Income Statement** form, completed by applicant and someone who knows the situation. Form must be signed and have the current date.
